Technology innovation drove efficiencies and business volumes

It is also the first to introduce FX withdrawal from ATMs, which led to the 120% increase in transaction volumes. First bank to launch overnight currency exchange service online

By listening to the needs to its customers, E.SUN launched the first overnight currency exchange service on both internet and mobile platforms. This is to cater to the increasing global nature of its clients' businesses and as a result, transaction volumes grew by over \$100 million.

About 1,000 delegates attended the awarding ceremony, consisting of industry specialists, senior bankers, regulators, service providers, and decision makers from leading institutions in Asia, the United States, Europe, and Latin America, where opinions and responses of practitioners to global issues are shaped.
